Wisconsin Trading Clearinghouse

RES has received the notice of intent to award the contract for the Wisconsin Trading Clearinghouse. The Clearinghouse is meant to help reduce the administrative burden while facilitating phosphorus trading between generators and users.

The Clearinghouse will act as a one stop shop where credit users will be able to easily identify availability and quickly verify the price of credits and credit generators will be able to register credits that will then be available for sale.
